The goods and services shown below are those we can provide to our customers. You may choose only the items you desire. However, any funeral arrangements you select will include a charge for our services. If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral and merchandise you selected.

This list may not include prices for certain items that you select, such as cemetery charges or crematory services, flowers and newspaper notices. The estimate or final price for those items will be shown on the itemized statement describing the funeral services and merchandise you selected. We charge you for our services in buying certain items.

Alternative Services

The charges for direct cremation and direct burial shown below include only the following descriptions.

Direct Cremation:

Range of prices \$1,075.00 to \$1,175.00

Our charge for direct cremation includes: local transfer of remains to the funeral home, obtaining required authorizations, services of funeral director and staff, transportation of the body by livery to designated crematory and return of cremains to the funeral home. There is an additional charge of \$1.00 per mile for transfer or transportation by funeral home livery beyond a 35 mile radius from funeral home.

If you want to arrange a direct cremation you may use an unfinished wooden box or an alternative container. Alternative containers can be made of heavy cardboard, pressed wood or composite materials (with or without outside coverings), or may be pouches of canvas or other materials.

THE DIRECT CREMATION CHARGES **DO NOT** INCLUDE CREMATORY CHARGE.

Direct Burial:

Range of prices \$1,685.00 to \$2,480.00

Our charge for a direct burial includes: local transfer of remains to the funeral home, obtaining required authorizations, services of the funeral director and staff, transportation of the body by livery to local cemetery. There is and additional charge of \$1.00 per mile for transportation by funeral home livery beyond a 35 mile radius from funeral home.

THE BURIAL PRICES DO NOT INCLUDE CEMETERY CHARGES.

- Direct Burial A:** (As described above) With minimum cloth covered casket.....\$2,480.00
- Direct Burial B:** (As described above) With container* provided by client.....\$1,685.00

Transfer of Remains to the Funeral Home: (Includes personal, equipment and vehicle.)

Local: Within 35 mile radius.....\$220.00

There is an additional charge of \$1.00 per mile for transfer or transportation by funeral home livery beyond 35 mile radius.

Preparation of Remains:

Embalming: (Including use of preparation room).....\$345.00

Embalming.....\$245.00

Preparation Room.\$100.00

Embalming of Autopsied Remains\$395.00

In New York State, embalming is not required by law. If you do not want embalming you have the right to choose an arrangement which does not require you to have embalming such as direct cremation or direct burial. If you select certain funeral arrangements, such as viewing or an open casket funeral, embalming may be required by the funeral home.

Other Preparation of Remains: (Excluding Embalming) Preparation of remains unless selected, is not required for direct cremation or direct burial.

Topical Disinfection:\$70.00

Custodial Care:\$95.00

Custodial Care will not be charged on days when embalming or other preparation of the remains occurs, visitation is held or a funeral service is conducted. Custodial care begins the midnight following embalming. Charged per 24 hours period or part there of.

Limited Services:

Forwarding of Remains to Another Funeral Home \$2,100.00

This charge includes local transfer of remains to the funeral home, other necessary local transportation of the deceased by livery, obtaining required authorizations, services of funeral director and staff, and use of facilities. Transfer or other transportation by funeral livery beyond 35 mile radius is subject to an additional charge of \$1.00 per mile. Transportation by common carrier is not included in the above charge.

Receiving Remains from Another Funeral Home \$1,755.00

This charge includes local transfer of remains to the funeral home, other necessary local transportation of the deceased by livery, obtaining required authorizations, services of funeral director and staff, and use of essential facilities. Transfer or other transportation by funeral livery beyond a 35 mile radius is subject to an additional charge of \$1.00 per mile. This charge does not include additional items of service, merchandise, facility use and livery that the customer may wish to select. Transportation by common carrier is not included in this charge.

Cash Advances:

Services and merchandise provided as cash advance items will be billed at the same amount paid by the funeral firm. Payment for these items will be due at the time of funeral arrangements. The following items will be considered:

Payment Policy:

Funeral arrangements can be a difficult task and one for which many are not well prepared. One of the ways we accommodate families in this regard is to offer different payment options for the expenses involved. Each family needs to consider which option best suits its needs.

- 1. We accept checks or cash as a family prefers.**
- 2. We accept Visa or Master Card for all or part of the funeral home charges.**
- 3. We accept payment from a prearranged trust account that has been established with PrePlan or a local bank.**
- 4. Insurance assignment, with policy presented at the time of funeral arrangements. We can assist the family with most insurance claims and there is no charge for handling these applications.**

Financial arrangements other than the above need to be discussed and agreed upon prior to the conclusion of funeral arrangements. It is not our policy to wait for payment from an Estate. The beneficiaries of an Estate and/or the individuals who engage us are expected to pay for all expenses, and they will be the first to be reimbursed from Estate assets. It is our intention to assist each family any way we are able with these financial arrangements.
