Prices Subject To Change Without Notice

The Federal Trade Commission (FTC) and the New York State Dept. of Health both require that certain disclosures be made by funeral providers on the General Price List. Although these disclosures may appear to be similar, they are not exactly the same. This General Price List contains both sets of the required disclosures. The disclosures required by the FTC, when different from those required by the Department of Health, are preceded by the letters "NYS."

(FTC, NYS) The goods and services shown below are those we can provide to our customers. You may choose only the items you desire. However, any funeral arrangements you select will include a charge for our services. If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral and merchandise you select.

(FTC, NYS) This list may not include prices for certain items that you select, such as cemetery charges or crematory charges, flowers and newspaper notices. The estimate or final price for those items will be shown on the itemized statement describing the funeral service and merchandise you select. We charge you for our services in buying certain items.

Alternative Services:

The charge for direct cremation and direct burial shown below include only the following descriptions:

Direct Cremation:

NYS – If you want to arrange a direct cremation, you may use an unfinished wooden box or an alternative container. Alternative containers can be made of heavy cardboard, pressed wood or composition materials (with or without an outside covering), or may be pouches of canvas or other materials.

FTC If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition material (with or without the outside covering). The container we provide are alternative container and unfinished wooden box.

Our charge for a direct cremation includes: local transfer of remains to the funeral home, obtaining required authorizations, service of funeral director and staff, transportation of the body by livery to designated crematory and return cremains to funeral home. There is an additional charge of \$2.00 per mile for transfer or transportation by funeral home livery beyond a 35 mile radius from funeral home. THE DIRECT CREMATION CHARGES DO NOT INCLUDE CREMATORY CHARGES

Our charge for direct burial includes: local transfer of remains to the funeral home, obtaining required authorizations, services of the funeral director and staff and transportation of the body by livery to local cemetery. There is an additional charge of \$2.00 per mile for transportation by funeral home livery beyond a 35 mile radius from the funeral home.

In New York State, Embalming is not required by law. If you do not want embalming you have the right to choose arrangements which does not require you to have embalming such as direct cremation or direct burial. If you select certain funeral arrangements, such as viewing or an open casket funeral, embalming may be required by the funeral home. FTC Embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with a viewing. If you don't want embalming, you usually have the right to choose an arrangement such as direct cremation or immediate burial that does not require you to pay for it.

Other Preparation of Remains:

(Excluding Embalming) Preparation of the remains, unless selected, is not required for direct cremation or direct burial.)

Topical Disinfection:.....**\$125.00**

Custodial Care:.....**\$95.00**

Custodial care will not be charged on days when embalming or other preparation of the remains occurs, visitation is held or a funeral service is conducted.

Custodial care begins 24 hours after embalming. Charged per 24 hour period. Or part thereof.

Arrangements:

The charge for our services will be added to the total cost of the funeral arrangements you select. However, this charge will not be added to the cost for direct cremation or direct burial, forwarding of remains or receiving because the prices for those services include this charge.

FTC This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for direct cremations, immediate burials, and forwarding or receiving remains.

Forwarding of Remains to Another Funeral Home ...**\$1710.00**

This charge includes local transfer of remains to the funeral home, other necessary local transportation of the deceased by livery, obtaining required authorizations, services of funeral director and staff, and use of facilities. Transfer or other transportation by funeral livery beyond a 35 mile radius is subject to an additional charge of \$2.00 per mile. Transportation by common carrier is not included in the above charge. Casket or alternative container is not included in this charge.

Receiving of Remains from Another Funeral Home ..**\$1330.00**

This charge includes local transfer of remains to the funeral home, other necessary local transportation of the deceased by livery, obtaining required authorizations, services of funeral director and staff, and use of essential facilities. Transfer or other transportation by funeral liver beyond a 35 mile radius is subject to an additional charge of \$2.00 per mile. This charge does not include additional items of service, merchandise, facility use and livery that the customer may wish to select. Transportation by common carrier is not included in this charge.

Cash Advances: (Must be Paid On The Day of Arrangements)

Services and merchandise provided as cash advances items will be billed at the same amount paid by the funeral home firm. The following items will be considered:

- Crematorium Charges
- Certified Copies of Death Certificates: \$10.00 per copy in Chautauqua County, New York
- Clergy Honorarium, Church Fee, Organist, Soloist, Sound Technician

- Vault Company Cemetery Equipment
- Newspaper Notices
- Common Carrier Charges
- Mortuary Shipping Firm Charges

Falconer Funeral Home, Inc. Payment Policy:

Funeral Arrangements can be a difficult task and one which many are not well prepared. One of the ways we accommodate families in this regard is to offer different payment options for expenses involved. Each family needs to consider which payment option best suits their needs.

1. We accept **checks, certified checks, money orders or cash.**
2. **We accept Visa or Master Card only for Funeral Home Charges.**
3. **Prepaid funeral trust account** established with Falconer Funeral Home which has been established with bank or trust company.
4. **Life Insurance Assignment** of personal life insurance policy presented at time of funeral arrangements. We must have complete cooperation of all parties involved: beneficiary, insurance company and the insurance policy value must be greater or equal to funeral home charges. Beneficiaries must be 18 years of age or older, living and present at the time of arrangements. If the beneficiaries are under the age of 18 or deceased then this is not an option for payment. We cannot except company, group or Veteran life policies.
5. **One Half of Funeral Home Charges Must Be Paid On The Day of Arrangements or within 2 days after funeral arrangements.** We accept cash, check, money order, certified check, Visa or Master Card. The remaining balance must be paid within 20 days of arrangements, by cash, check, money order, Visa, Master Card or assignment on life insurance policy as described above in option 4.

Cash Advancements Must Be Paid On The Day of Funeral Arrangements By Cash, Check or Money Order. We do not accept credit cards for cash advancements.

It is the policy of Falconer Funeral Home, Inc. not to wait for the proceeds of the deceased estate to pay for funeral expenses. The beneficiaries of the estate and/or the individuals who engage us are expected to pay for all funeral expenses by one of the options listed above. The beneficiaries will be reimbursed from estate assets. It is our intention to assist each family any way we are able with these financial arrangements. Financial arrangements other than the above need to be discussed and agreed upon prior to the conclusion of funeral arrangements.
